And defines the rights and responsibilities of both. The Outfitter will be defined to mean himself and his employees.

The Outfitter agrees to provide complete guiding service which is to include all meals while in the field, trophy and meat care, and lodging and transportation while in the field. The Outfitter also agrees to conduct all hunts in a legal and ethical manner relative to the specific location of the hunt. Additionally, the Outfitter is not responsible for delays caused by weather, war in the United States, government regulation, disaster, curtailment of transportation facilities, or any other emergency making it impossible or illegal to conduct the hunt.

The Client is responsible for transportation to and from Cordova, Alaska or other point of departure into the field, charter costs to and from the field, in-town lodging and meals (if necessary), costs related to packaging and shipping trophies and/or meat from the field to their final destination, and all necessary tags and licenses.

It shall also be understood that the client will be allowed to hit and wound only one animal of each species he is hunting, whether with an arrow or a bullet. If the wound is not immediately fatal, every effort will be made to relocate that same animal during the hunt to provide another opportunity to harvest it, however the client will not be allowed to shoot at a different animal of the same species. This puts the responsibility of good shooting skills on the client, and helps to ensure that the hunt is conducted in the most ethical manner possible.

Twenty five percent (25%) of the cost of the hunt is due at the time of booking. Another (25%) will be due January 10th of the year in which the hunt will be conducted, and the balance is due sixty (60) days prior to the hunt. A cancellation at any time prior to the hunt by the Outfitter will refund one hundred percent (100%) of the money paid by the client. In the event of a cancellation by the client, the Outfitter will refund 50% of the deposit received if the cancellation occurs more than one year from the date of the start of the hunt. If the cancellation occurs 6 months prior to the start of the hunt, or the year of the hunt, which ever is longer, the deposit(s) will not be refunded. The client will have the option of rebooking to the next available hunt and crediting the deposit toward that hunt.

The Outfitter shall maintain all reasonable care and precaution for the safety of the Client, but the Client recognizes that he/she is taking part in an outdoor activity involving inherent risks. These risks may include exposure to difficult and dangerous terrain, exposure to severe weather conditions, and exposure to dangerous game and hunting situations. Except for the negligent action or inaction by the Outfitter, the Client accepts such inherent risks, assumes liability for the same, and holds the Outfitter harmless from any damages and expenses.
